Dear Members and Friends:

We are pleased to extend an invitation to you and your spouse or significant other to attend the 2024 Convention of the National Association of Pipe Coating Applicators (“NAPCA”) to be held April 16-19, 2024 at the Westin Hilton Head Island Resort & Spa in Hilton Head, South Carolina. NAPCA has not held a convention in Hilton Head in decades and we know that everyone will have a wonderful time and enjoy the physical beauty of the location, as well as the speakers, events, and networking opportunities that are the hallmark of the NAPCA conventions. Last year’s convention, as well as the summer workshop, were huge successes and we are expecting the same in 2024. Only NAPCA members (including retired members) in all categories, their spouses and significant others, and individuals invited by NAPCA are eligible to participate in the convention. All delegates are encouraged to bring their spouses to the convention, and most people do.

The remainder of this letter and enclosures will provide you detailed information so that you may better make your plans to attend. **The deadline for making your hotel reservations is March 25, 2024. After this date available rooms are not guaranteed. The deadline for registering for the convention through NAPCA is April 10, 2024.** This letter and all enclosures may be found at the NAPCA website [www.napca.com](http://www.napca.com) by clicking on the “**2024 Convention Registration**” link on the homepage.

### **SPECIAL NOTICE – CONVENTION SCHEDULE**

Over the years we have modified the convention schedule to accommodate the desires of our members. Based on much feedback we moved the starting and ending dates of the convention up by a day so members can travel home on Friday and spend the weekend with family if they choose to do so. This was met with much appreciation from members so this scheduling model will be used for all future conventions unless members prefer a change. Accordingly, this year, the President’s Reception, which opens the convention, begins at 7:00 pm on **Tuesday, April 16, 2024**, and the signature party and dinner will immediately follow such reception. Additionally, the NAPCA Final Banquet, which concludes the convention, takes place at 8:00 pm on **Thursday, April 18**. To ensure you arrive in time for all of the convention events, you will want to schedule your flight to allow enough time to freshen up before the President’s reception starts at 7:00 pm.

Golf will take place on Wednesday (with a sponsored reception and then dinner on your own later that evening), the NAPCA Luncheon, the Associate and Regular Member meetings, and the Final Banquet are on Thursday. ***To ensure you can attend the Final Banquet Thursday evening please make a concerted effort to schedule your departing flights for Friday if you choose to leave Friday and not stay the weekend.*** All told, please pay careful attention to the convention schedule that is included in the packet.

## **2024 CONVENTION PROGRAM**

All details regarding the convention are set forth in the enclosed convention packet, on the registration link included in the registration announcement email, and at the NAPCA website. Included in this packet you will find a Supplemental Newsletter providing important information, Convention Program Agenda, NAPCA Convention Registration Form, Hall of Fame Nomination Form, and the Information Sheet for Spouse Events and local Restaurants.

This year's business program will present timely issues critical to the plant pipe coating industry and those of its service and materials suppliers. On Wednesday we will be treated to an ever-important presentation by John "FBI John" Iannarelli, Former FBI Agent & Current Corporate Speaker, otherwise known as the "Voice of Cyber & Security," who will discuss timely issues concerning "Cybersecurity – Understanding Business Vulnerabilities, Recognizing Threats and Avoiding Becoming a Victim, and Combatting Cybercriminal Attacks." On Thursday we will have two speakers. The first speaker will be Stephen Rapp, P.E., Technical Director, Materials Engineering, Pipeline Integrity, Enbridge Gas Transmission, who will address "A Pipeline Operator's View of Hydrogen and CO2 Pipeline Opportunities." The second speaker is currently being secured and we will notify you of the speaker's identity and topic as soon as this is finalized. Please feel free to invite your spouses or significant others to attend any of the general session presentations if they would like to do so.

## **BREAKOUT SESSIONS**

In addition to the general session presentations, there will be breakout sessions on Wednesday and Thursday mornings, which will address emerging technologies in the pipe coating industry and presentations on other relevant topics. NAPCA Associate Trustee and Board Secretary, Brandon Blair of Sherwin Williams Company, this year's breakout session coordinator, is still in the process of lining up presenters and those individuals, their companies, and their topics will be provided to you as soon as such is final, but before the convention commences.

Please be prepared to share the topic you desire to address. Each breakout session slot is approximately 20 minutes.

There will not be a line pipe manufacturers meeting at the 2024 convention. Rather, all efforts will be focused on developing a more focused informative session with presentations that will take place after the workshop in August 2024.

## **NETWORKING EVENTS AND ENTERTAINMENT**

Breakfasts, lunches and all afternoon and evening activities are geared for spouse participation. The first official event of the convention on April 16 will be the President's Reception, which is an excellent time for everyone to renew old friendships and make new acquaintances. Please note the dress for this event is dressy casual - no coats or ties required. Our main theme event will be the "NAPCA Game Night Party" immediately following the President's Reception. There will be music, outstanding food, entertainment, and dancing that will make the evening most enjoyable. In addition, you will have the opportunity to play a variety of games, including foosball, pool, air hockey, ping pong, darts, a variety of party games, and various arcade games, if dancing is not your thing or if you require a break from dancing. The Final Banquet will be held on Thursday, April 18, where NAPCA Hall of Fame inductees will be revealed and awards will be made for the golf, pickleball, and gin rummy tournaments. The golf tournament will be on Wednesday and the gin rummy tournament, as well as the pickleball tournament, will take place on Thursday afternoon. In addition, spouse events will occur on Wednesday and Thursday.

Attendees will be pipe coating applicators, pipe coating material and equipment manufacturers and suppliers, providers of services, line pipe manufacturers, pipe stocking distributors, pipe transportation and stringing companies, consulting firms, independent inspection companies and others associated with the plant pipe coating industry as well as representatives from pipeline magazines. Many delegates and guests from foreign countries will attend as well.

Opportunities to network with customers and suppliers and to cultivate and develop valuable friendships will be provided by our social and sporting activities. Substantially all events and meals at the convention will be sponsored. Our sponsors allow us to provide quality conventions, and we thank them for their generosity.

### CONVENTION REGISTRATION

The convention registration fee is \$850.00 for each delegate and \$350.00 for each spouse or significant other. To encourage retirees from the pipe coating industry to attend the convention NAPCA offers a reduced convention registration fee for retired delegates of \$350.00 and a reduced fee for spouses or guests of retired delegates of \$250.00. **These prices apply if you register prior to February 26, 2024.** On February 26, the fees will be as follows: (1) delegates - \$950.00; (2) delegate spouse or significant other - \$400.00; (3) retired delegates - \$450.00; and (4) retired spouses or guests - \$350.00. Therefore, it is in your interest to register early. We encourage all delegates to **register on-line, which can be accessed through the NAPCA website [www.napca.com](http://www.napca.com)** and clicking on the **“2024 Convention Registration”** link on the homepage or through the link incorporated in the registration email sent to you. Through this method you may charge the convention registrations on any major credit card. For those who do not wish to register on-line, you may complete and return the enclosed Convention Registration Form with appropriate fees to our office **no later than April 10, 2024.** You may fax the form first and then mail it with your check. NAPCA does not have mailing or email addresses for most retirees. We request that each member company contact its retirees who might be interested in taking advantage of the reduced convention registration fees and refer them to the NAPCA website for the convention package or forward the convention package to them.

### GENERAL INFORMATION, HOTEL RESERVATIONS & GOLF

The Westin Hilton Head Island Resort & Spa is the perfect location for just about any occasion. The Westin is located on a lively, vibrant stretch of the Atlantic Ocean and promises a stimulating experience for NAPCA members. This oceanfront resort will be a perfect backdrop for our Fifty-Ninth Annual Convention! The Westin boasts several excellent restaurants, three outdoor pools, direct beach access, and several nearby world-famous golf courses. This celebrated beachfront resort is routinely voted as one of the 10 best resorts in the Carolinas, most recently in 2023. The resort not only has impeccably maintained and beautiful grounds, but is also within easy reach of popular attractions. Sip a cold beverage in a cabana by one of the onsite pools or play a round at one of the many spectacular golf courses in the immediate area. In particular, the nearby Port Royal Golf Club boasts two 18-hole courses and is within walking distance. Whether you enjoy sunning yourself by the pool, viewing endless beach and ocean views, shopping at the many stores close by, golfing, or just relaxing, the Westin is a spectacular venue for our convention.

Within a short distance of the hotel, the Robber's Row Course at the Port Royal Golf Club will be the location for the NAPCA Golf Tournament. Golf Digest has rated the course within the "Top 75 U.S. Golf Resorts." The course is located on the scenic marsh side of the Port Royal Plantation and cuts through beautiful strands of magnolia and live oaks. This course sits atop former Civil War grounds and features historical markers throughout the course, describing events which took place on the Island. If you desire to play the Robber's Row Course, the other course located at the Port Royal Golf Club (the Barony Course), or other area courses within the Hilton Head Island Heritage Golf Collection outside of the tournament, reservations may be made through the Heritage Golf website (<https://hiltonheadgolf.net/book-tee-times>) or by phone at (843) 681-1750. **It is recommended that you make tee times as far in advance as possible.**

**We encourage you to make your hotel reservations on-line at the reservations website set up for NAPCA. This website will automatically charge you the special NAPCA group rate of \$319.00 per night for single or double occupancy that we have negotiated. A link to this website is contained within the registration link on the NAPCA “2024 Convention Registration” page, as well on the registration email you were sent. If you choose not to make your hotel reservation on-line, you may make your reservation by calling the Westin Hilton Head Island reservation line at 843-681-**

4000 ensuring to tell them you are part of the National Association of Pipe Coating Applicators so that you can get our group rate. **The important thing to remember is that you must make your room reservation no later than March 25, 2024 to ensure you will have a room.** We expect the resort will be busy in April, and, if you miss the deadline, you cannot be assured of having a room, much less one at the negotiated rate.

Cruising the salt-marsh ecosystem in search of dolphins is a popular activity in Hilton Head, but unlike other similar tours, this dolphin and nature tour uses small boats so wildlife isn't scared away easily. Sail along the water from Shelter Cove Marina, down Broad Creek, and into Calibogue Sound, while keeping a lookout for Atlantic bottlenose dolphins, birds, and other animals that call the area home. This dolphin and nature tour gets you off the beach and on the water. Hilton Head Island is known to have active populations of Atlantic bottlenose dolphins and the small boats used don't intimidate the wildlife, making sightings common. Recommended attire is comfortable walking shoes, sunglasses, and plenty of sunscreen.
